

Fair Rules

Vendors

1. **Tables**
 - a. Tables are 8' x 2'.
 - b. Tables are \$25 each.
 - c. You may request electrical access, but it is not guaranteed. Make sure to bring your own, labeled, extension cords.
2. **Payment**
 - a. Payment is due when you register for the fair.
3. **Communication is via Email**
 - a. We only use email to send confirmations and changes.
4. **How to Reserve Tables**
 - a. Email adoptions@jraar.org for an application.
 - b. Events staff can approve or deny any registration for any reason.
 - c. Once your registration is approved, you will be sent a link to purchase table tickets electronically or pay with check or money order via snail mail. The mailing address is 736 Arthur Street, Menasha WI 54952.
 - d. Your table will not be reserved until the tickets are purchased.
5. **Cancellation and Transfer Policy**
 - a. Tables may not be cancelled on short notice (2 weeks). Tables cancelled over two weeks in advance of the event will receive a full refund.
 - b. If you register for a table, you are responsible for paying for it, whether you can make the fair or not. You are solely responsible for paying for your table(s).
 - c. Tables are first come first serve, please pay for your tickets before they sell out.
 - d. You may not transfer a reservation to another party.
6. **Room Layout**
 - a. The room layout changes from fair to fair.
 - b. Do not assume you will get the same table as last time.
 - c. We try to accommodate requests for electrical outlets, but cannot guarantee them.
7. **General Rules**
 - a. Day Before Move-in is between 5:00 PM and 9:00 PM
 - b. Day of Move-in is between 8:00 AM and 10:30 AM only. Please have all your items in the room BY 10:30 AM. After 10:30 AM, attendees begin to line up and safety becomes an issue.
 - c. Prior to 11:00 AM, only vendors and JRAAR staff may enter the swap rooms.
 - d. Please encourage your pre-paid sales to come at noon for pickup and to pay an admission. This is fair to everyone.
 - e. No personal sales or trades of any kind will be allowed on Fair premises without prior approval of an Events Chairperson.
 - f. Limit of one vendor allowed per registration.
 - g. Additional helpers may enter the room early to help you set up, but must pay General Admission. Exceptions are made for young children of vendors.

- h. JRAAR reserves the right to remove anyone who is disruptive or who is behaving in an unsafe manner.
 - i. Only items related to the theme of the event may be sold. I.e. crafts at a Craft Fair, fish at a Fish Fair etc. No exceptions without express permission from an Event Chairperson.
 - j. Vendor is responsible for collecting any sales tax that may be due.
- 8. Live Animal Sales (Where Applicable)**
- a. Live animals must be raised by the vendor and the vendor only. No imported animals will be allowed with the exception of fish imported ethically.
 - b. Species prohibited or illegal in Wisconsin may not be sold.
 - c. No sales of turtles with a carapace length under 4 inches allowed.
 - d. Artificially dyed or tattooed fish or other organisms will not be sold.
